In the mean while the parliament approval has given to the Samurdhi Development Act No.2 of 2017. After issuing the relevant gazette notification, the name of the Department of Divineguma Development and the names of the associated community based Bank network, will be amended as bellow.

Hence the name boards exhibited on Divineguma Community based Banks and Divineguma Community based Bank Society buildings should be changed immediately.

Accordingly instructions provided below should be followed in rearranging the name boards.

01. The name board should be prepared with 5ft length and 3ft width.
02. The background Colour should be " Golden Yellow " and the letters should be black.
03. The finished name board should be fixed steadily to the ground using two 1 ½" G.I pipes.
04. If the Community based Bank or Bank Society is situated away from the main road, above mentioned name board should be fixed near the bank building and a board of 3 ½ ft length and 2ft width should be prepared and fixed near the main road for guidance.

Instructions on how to re - use the prevailing name board and how to adjust the content.

- a) If the condition of the prevailing name board is very good,
 - Prevailing colours should be removed and above mentioned colour should be applied to the back ground. The relevant letters should reconstituted in black colour according to the model provided.
 - Maximum credit limit for the task is Rs. 7500/- The expenses should be beared from bank funds.
- b) If the prevailing name board cannot be re-used, a new name board should be prepared.
 - The Name board should be prepared using above mentioned dimensions.
 - Back ground colour should be "Golden Yellow" and letters should be black.
 - Maximum credit limit for this will be Rs.20,000/- Expenditure should be beared using bank funds.
- c) The directing name boards should be newly prepared.
 - Back ground should be "Golden Yellow" and the letters should be black
 - Maximum credit limit is Rs. 6,000/- and expenditure should be beared using bank funds.
 - The board should be fixed to the ground steadily using two 1 ½" inch G.I. pipes.

01. Samurdhi Community based Bank / Bank Society managers are responsible in preparing the name boards and reporting that to the District Samurdhi Office.

A model name board is annexed here with this.
